COUNCIL DECISION 2010/573/CFSP of 27 September 2010 concerning restrictive measures against the leadership of the Transnistrian region of the Republic of Moldova

- Restrictions on admission for persons who are responsible for preventing progress in arriving at a political settlement of the Transnistrian conflict in the Republic of Moldova or for the design and implementation of the campaign of intimidation and closure against Latin-script Moldovan schools in the Transnistrian region of the Republic of Moldova, as listed in the Annex.

COUNCIL DECISION 2011/171/CFSP of 21 March 2011 amending Decision 2010/573/CFSP concerning restrictive measures against the leadership of the Transnistrian region of the Republic of Moldova

- Extends the validity of the restrictive measures until 31 March 2012;
- Suspends the restrictive measures until 30 September 2011.

COUNCIL DECISION 2011/641/CFSP of 29 September 2011 amending Decision 2010/573/CFSP concerning restrictive measures against the leadership of the Transnistrian region of the Republic of Moldova

- Extends the validity of the restrictive measures until 30 September 2012;
- Suspends the restrictive measures until 31 March 2012.

COUNCIL DECISION 2012/170/CFSP of 23 March 2012 amending Decision 2010/573/CFSP concerning restrictive measures against the leadership of the Transnistrian region of the Republic of Moldova

- Suspends the restrictive measures until 30 September 2012;
- Amends the list of persons to whom the restrictive measures apply.

COUNCIL DECISION 2012/527/CFSP of 27 September 2012 amending Decision 2010/573/CFSP concerning restrictive measures against the leadership of the Transnistrian region of the Republic of Moldova

- Limits the listing criteria to persons who are responsible for the design and implementation of the campaign of intimidation and closure against Latin-script Moldovan schools in the Transnistrian region of the Republic of Moldova, as listed in the Annex;
- De-lists all persons subject to restrictive measures;
- Extends the validity of the restrictive measures until 30 September 2013.

COUNCIL DECISION 2014/381/CFSP of 23 June 2014 amending Decision 2010/573/CFSP concerning restrictive measures against the leadership of the Transnistrian region of the Republic of Moldova

- Extends the validity of the restrictive measures until 31 October 2014

- Extends the validity of the restrictive measures until 31 October 2015
