### [United Nations Security Council Resolution 661 \(1990\)](#)

- ban on export (para. 3a) and import (para. 3b) of all commodities and products originating in Iraq;
- embargo on arms and related materiel (para. 3c);
- prohibition to make available to the Government of Iraq or to any commercial, industrial or public utility undertaking in Iraq or Kuwait of any funds or any other financial or economic resources (para. 4).

### [United Nations Security Council Resolution 1483 \(2003\)](#)

- embargo on arms and related materiel (para. 10);
- prohibition on trade or transfer of cultural goods (para. 7);
- terminates the prohibitions related to trade with Iraq and the provision of financial or economic resources to Iraq established by resolution 661/1990, except for the prohibitions related to the sale or supply of arms and related materiel (para.10);
- transfer of funds and economic resources to the Development Fund for Iraq (para. 20);
- immunities (para. 22);
- freezing of funds and economic resources (para. 23).

### [United Nations Security Council Resolution 1518 \(2003\)](#)

- create a Committee of the Security Council to continue to identify pursuant to paragraph 19 of resolution 1483 (2003) individuals and entities to be subjected to sanctions.

### [United Nations Security Council Resolution 1546 \(2004\)](#)

- introduces an arms embargo;
- introduces a travel ban for certain individuals;
- immunities.

### [Common Position 2003/495/CFSP](#)

- confirmation of embargo on arms and related materiel.
- restrictions on trade in cultural goods.
- freezing of funds and economic resources.
- transfer of such funds and economic resources to Development Fund for Iraq.

*Note: the restrictions concerning payment for petroleum and gas exported by Iraq and the immunities expired on 30 June 2011*

- clarifies scope of freezing of funds and economic resources.
