Council Decision 2010/639/CFSP concerning restrictive measures against certain officials of Belarus – valid until 31.10.2012

Restrictions on admission (art. 1 (1))

Freezing of funds and economic resources (art. 2 (2))

Prohibition of the sale, supply, transfer or export of arms and related material of all types, as well as equipment which might be used for internal repression (art. 3a)
